Respondent Demographics:

- 18% year-round residents, 82% part-time
 - Slightly fewer PT resident respondents spending more time in the area due to the pandemic
- Years at current residence
 - 60% 20+ years/multi-generational
 - 24% 6-19
 - 15% >1-5
- 77 member respondents contain 325 HH members:
 - 5% 75+
 - 32% 55-74
 - 28% 25-54
 - 16% 19-24
 - 9% 13-18
 - 11% 12 & under
