As plans progress for the work, the Association will be in contact with our constituents via e-mail and social media.

Then and Now:

Somewhere in the area of 63 West Shore Road stood the Wilson House Hotel, another thread in a tightly woven fabric of the now-defunct hospitality industry which encompassed Lake Waramaug. J.B. Wilson was the proprietor, and his wife, Agnes, was a suffragette who organized a "literary" group of women there. The Hotel, once boasted as the "Largest Hotel on the Most Beautiful Lake in Connecticut," burned down

during the early part of the 20th Century. Now it is a private residence for which a driveway has been added and part of the exposed rock ledge has been removed. The horizontal overhang is found in the center part of the boulder in the old photo, a portion having been removed for the driveway.


